This special issue focuses on sexual boundary violations. Our intent is clear: We want to promote discussion and clarification on this topic. Underlying this special issue is the belief that a study of sexual boundary violations can potentially avert reenactments. As we are all potentially vulnerable to boundary transgressions, including sexual ones, such study is essential. In this first overview article, we present a brief summary of some of the major topics relevant to sexual boundary violations as well as an overview of the articles included in this special issue on sexual boundary violations.

A young female patient was convinced that she was in love with her male therapist. She spoke of her love for him incessantly. The therapist was flattered, scared, and tempted. When the male supervisor discussed this in supervision, the 80-ish year old female supervisor who was clearly disabled from a childhood disease said to her supervisee: "You should see the handsome 20-somethings who are in love with me!" The supervisor then explained that it was the patient's absolute right to try to seduce his analyst and, similarly, it was the analyst's obligation to analyze the behavior.

This special issue focuses on sexual boundary violations. Our intent is clear: We want to promote discussion and clarification on this topic. Underlying this is the belief that a study of sexual boundary violations can potentially avert reenactments. As we are all potentially vulnerable to boundary transgressions, including sexual ones, such study is essential.

In this first overview article, we present a brief (a) summary of some of the major topics relevant to sexual boundary violations and an (b) overview of the articles included in this special issue. A few introductory comments are in order: First, in this volume we use "mental health professionals" and "psychoanalyses" interchangeably. We do so because mental health professionals of every theoretical orientation commit sexual boundary violations. The authors of this special issue are psychoanalysts and they write, for the most part, about sexual boundary violations within psychodynamic and psychoanalytic treatment. It should be clear, however, that psychoanalysts and psychodynamically oriented ther-

apists are not more prone to boundary violations than other mental health professionals. In fact, psychoanalytic and psychodynamic therapists have lower prevalence rates of misconduct than therapists of other orientations (Celenza, 2007). Regardless of whether it is addressed in treatment and/or whether the type of treatment utilized is designed to make use of transference, a transference-based relationship will develop in the course of treatment. The therapy process promotes unresolved transference-based relationships and can contribute to the patient's greater receptiveness to boundary violations.

A second point: While we are considering sexual boundary violations in treatment, sexual and other boundary violations occur in other related contexts such as in supervision or in an academic setting. While many of the issues are similar across settings, our focus here is limited to treatment. We refer readers interested in boundary issues in supervision and academia to comprehensive chapters in Gabbard and Lester (1995) and Celenza (2007).

Another associated point: This volume focuses mainly on sexual boundary violations or physical contact occurring in the context of a therapeutic relationship for the purpose of sexual pleasure. Not included in this definition is the occasional handclasp or embrace, when the analyst's intent is other than for sexual pleasure. Of course there are boundaries other than sexual that are violated within treatment. While some reference is made to other violations throughout this volume, these are not the primary focus here. It should be noted, however, that nonsexual boundary violations are more common than sexual ones and that therapist-patient sex may be the result when there is a violation of nonsexual boundaries. This is the "slippery slope" in which boundary violations that begin as inconsequential and nontoxic rocket to major and destructive ones. Further, considerable harm may be done to both the patient and the process even when the culmination of boundary violations is not sexual (Gabbard & Lester, 1995).

Fourth, the literature supports that more violations are committed by male than female therapists (Schoener, Milgrom, Gonsiorek, Luepker, & Conroe, 1989) and more violations are perpe-
