#### B- Un jury

Selon l'autorité organisatrice de l'examen, chaque candidat est généralement entendu par un jury d'oral composé de trois personnes, voire par un jury plus important en nombre.

Les jurys d'oral sont composés dans la même logique que le jury plénier du concours qui comprend réglementairement trois collèges égaux (élus locaux, fonctionnaires territoriaux, personnalités qualifiées).
