Acceptance of all or part of the goods or services shall not

- I. Waive Buyer's right to cancel or return all or any portion of the goods or services that do not conform to the Purchase Order
- II. Bind Buyer to accept future shipments of goods or services
- III. Preclude Buyer from making any claim for damages or breach of warranty. All purchases are subject to inspection and rejection by Buyer notwithstanding prior payment. Rejected goods will be returned at Seller's expense for transportation both ways and all related labour and packing costs. No goods returned as defective by Buyer shall be replaced by Seller without written permission of an authorized agent of Buyer.

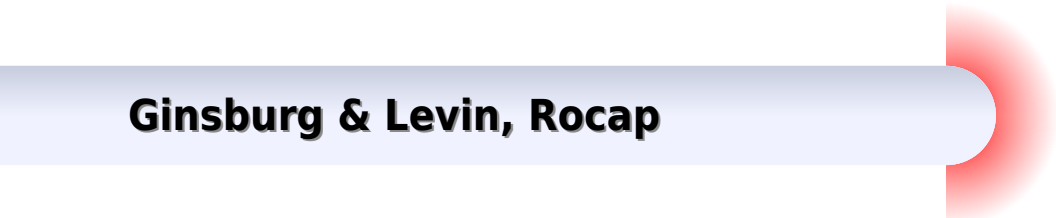
Buyer may at any time, by written order, make changes within the general scope of this Purchase Order in any one or more of the following:
